## Permission Form for MinorVolunteers

Dear Parent or Guardian,

Your child or ward has signed up to participate in a Keep Truckee Meadows Beautiful beautification project. Due to the nature of the project, your child or ward will not be directly supervised and, therefore must have your permission to participate in the project. Please carefully read the Notice and Agreement below before signing this document.

Notice and Agreement by Parent/Legal Guardian:

In order for my child or ward to volunteer at any Keep Truckee Meadows Beautiful (KTMB) program or event, I, the volunteer's parent or legal guardian, understand and agree as follows:

1. I understand that my child or ward is not an employee of KTMB, or any participating municipality, government organization, sponsor or partner while acting within the scope of this agreement and, as such, my child or ward is not covered under or eligible for KTMB's, or any participating municipality, government organization, sponsor or partner's Worker's Compensation and Employers Liability Insurance Policy or Program, or other insurance including medical or other benefits due an employee.
2. My child/ward is in good physical condition adequate to perform the duties for which my child or ward has volunteered and I agree to tell my child's or ward's supervisor of any significant change which would affect the ability of my child or ward to perform the duties.
3. I further understand that as a volunteer for KTMB, my child or my ward has certain liability protections provided by Nevada and Federal law. These protections are set forth in NRS41.480, NRS 41.485, the Federal Volunteer Protection Act of 1997 and other provisions of law.
4. I understand and agree, that KTMB or any participating municipality, government organization, sponsor or partner, is not responsible to defend, or hold harmless myself, my child or ward in any litigation that may result from actions while serving as a volunteer for KTMB.
5. I understand that the relationship between KTMB and a volunteer, such as my child or ward, is an "at will" relationship and may be terminated at any time without cause and without notice by either the volunteer or KTMB.
6. By signing this form, I agree to save and hold KTMB or any participating municipality, government organization, sponsor or partner harmless from all claims or suits for losses, liabilities, injuries, or other detriments which may be made against the named or their employees based on any intentional or negligent act or alleged intentional act or omission by the volunteer as the result of participation in volunteer activities.

In order to volunteer, your child **must** bring this signed form to the project site for **each time** he/she is participating. Thank you for your cooperation in this matter.
